Sewer Backups

You may have noticed the sewer work in courts 9 and 7, in October and November respectively. Tree roots penetrated the old pipes located in front of the units in both courts and, combined with what is flushed down toilets, created a sewage backup. The sewage backup occurred in the lowest level of the middle of the building, coming up through the drain in the basement floor, which is not a pleasant situation. The backups in both courts occurred on a Saturday but one occurred while the homeowner was away. The residents in other units of that building found backed up toilets and/or clogged drains in their basement and alerted CMC and the Board.

If this happens in your unit the first step is to call a plumber. The Mews has been using All Plumbing for its plumbing work but Dwyer was called in the second instance. The cost for snaking the drain was approximately \$1,000 each time. The Mews paid this cost because Mews owned trees penetrated the pipes

outside the building causing the backup. In both courts the yard had to be dug up and the pipes were replaced with PVC pipe. PVC is now used because it will not rot like cast iron or clay and cannot be penetrated by tree roots. The total cost of repairs for both courts will probably exceed \$100,000. This is due to the necessary repairs of the concrete and the interior of the residence where the backup occurred.

The Board is researching the option of hiring a contractor to examine all the sewage pipes looking for any potential damage via a camera. Alternatively, it may be more cost effective to purchase our own camera and have our maintenance guy, Steve Burcham, perform this work. Once research is complete for both options a decision will be made.

The Board has approved a contract to jet the lines on a yearly basis to remove debris and the lines in the Mews have been jetted for this year.

Preventing Sewer Backups

You can help prevent sewer backups and the costs associated with repairs. Your cooperation will help to keep our monthly fees low.

Only toilet paper and human waste should be flushed in toilets. The following should **NOT** be flushed down the toilet:

- Kleenex, paper towels or napkins
- Dental floss
- Hair
- Feminine hygiene products
- Baby & adult wipes (even those marked "flushable")
- Disposable diapers
- Condoms
- Pet waste & kitty litter

Backups are also caused by improper disposal of the following items in drains and garbage disposals. You should **NOT** put any of the following in your garbage disposal or sink drains:

- Grease/oil (let solidify and place in trash)
- Egg shells
- Coffee grounds
- Vegetables such as cornhusks, celery, cabbage, onions, potato peels, etc.
- Pulpy fruit and fruit seeds
- Chicken or fish bones
- Seafood shells (i.e., shrimp)
- Paint & caulk

Most garbage should go out with the trash; these items should never enter our sewer system. Thank you in advance for your cooperation.

Right of Entry

The Mews bylaws state that the condo association has the right to enter a unit if they suspect an emergency situation. Locksmiths should be aware that condominiums are co-owned and that an association has the right to enter and can be accompanied by a police officer if necessary. If you have a good relationship with a neighbor, it's a good idea to leave a key with them for emergencies. When the sewage backup occurred in court 9 it was several hours before a locksmith gained entry, exasperating the situation.

B-Building Update

Work has begun to update the common spaces in the apartment buildings and is progressing nicely. The contractor's plan is to complete three buildings simultaneously so that carpet can be installed on the same day for all three buildings. If you live in one of these buildings you will need to remove your belongings from the hallways on both levels. You will see a vast improvement to the décor once they are all complete. The Board would like to thank Sarah Skarda of court 2 for her work getting this project moving and continuing to work with our contractor to ensure everything is perfect.

Painting & Gutters

The Mews has kept several contractors busy over the past few months. Painting for courts 1-6 began in September and has continued through November. If you were here during the last painting cycle, you may have noticed that this cycle is taking a lot longer. On the recommendation of the Board of Fairlington Arbor, Kolas Contracting was hired for this painting cycle and they are doing the proper prep work instead of just painting over the old paint. They are scraping and sanding many years of accumulated layers of paint, as well as marking areas of rotted wood that need to be replaced. The Board has received great feedback from co-owners noting the excellence of the work being done by Kolas.

The Board approved a contract for Katchmark to replace the current four-inch gutters with six-inch gutters to improve water flow away from the building and reduce the potential for water seeping into basements. This work began in court 15 and will continue through all 15 courts until the work is complete. In removing the old gutters, Katchmark is also replacing rotted wood as it is found. Our maintenance guy, Steve Burcham, is supervising all work but please let CMC management know if you see any work that is not done properly.

Parking in the Mews

In accordance with the Mews Handbook you are required to have a valid vehicle registration in order to park on Mews property. If you are new to the community please do not forget to update your registration to your current address. Vehicles that are regularly parked within the County are required to display a valid county decal. Please review the state registration and licensing requirements at www.dmv.state.va.us. Arlington County requirements can be found at <http://taxes.arlingtonva.us/vehicles/vehicle-registration/>.

Winterize Your Unit

It's that time of year when the outside faucets need to be turned off to prevent pipes from bursting during freezing temperatures. Turn the water off from the inside first then open the outside faucet to drain any remaining water and leave the faucet in the open position. In most units, the shut-off valve for the backyard faucet is under the kitchen sink and the shut-off valve for the front faucet is in the basement next to, or above, the hot water heater. Hoses should be removed from faucets as the water trapped in the hose can travel back into your pipes and freeze.

Please take every precaution to prevent pipes from freezing by ensuring that your heat is on and the thermostat is set at a temperature that's high enough to keep your pipes

from freezing. This is especially important if you are away from home for an extended period of time. If residents do experience burst pipes, damages incurred to your unit and any other unit impacted, is the responsibility of the owner.

While you're outside turning off your faucets, please also check the downspouts that may be in your patio and clear away any leaves or other debris that may be blocking them. This ensures that water from heavy rain or melting snow can flow freely and does not back up and possibly enter your unit.

Loss of Water or Electricity

On October 29 several courts in the Mews were without water for 12 hours due to a water main break that occurred across the I-395 Bridge. The water was turned off at approximately 5:30 p.m. by Arlington County. If water is turned off at night or on the weekends, this is most likely due to a water main break and is controlled by Arlington County, not the Mews. You can call Arlington County's 24-hour hotline to confirm at 703-228-6555; do not call the CMC emergency number. This is no different than if the electricity goes out and you would call Dominion VA Power at 1-866-366-4357.

The Mews occasionally has to turn the water off for a specific court in order to perform repairs. This will typically occur during normal business hours and notices are distributed in advance.

CMC After Hours Emergency Number

The CMC Emergency number is 703-631-7200 and should only be called in the event of an emergency that occurs outside normal business hours. The association is charged \$50 for every phone call received by the CMC emergency center. Events that constitute an emergency are those that cannot wait until the next work day and are under the control of the management company. Examples of an emergency include, but are not limited to: your ceiling caved in due to water damage, fallen tree on your home, or you are experiencing a sewage backup in your basement. Please help us control costs and contact the appropriate party in the event of an emergency or loss of utility services.

Caroling & Cookie Exchange

The Recreation Committee has planned the Mews annual Caroling and Cookie Exchange for December 20th at 3:30pm. We will meet at the "Christmas tree" in Court 11 (3400 block of South Wakefield). We'll have jingle bells for the kids and songbooks will be provided. Caroling will be followed by hot cider, sweet treats, and a surprise visit from Santa back in Court 11. Tree Mapping

One of the long-term projects the Landscape Committee has tackled is to identify and map all trees in the Mews, which is no easy task. The reason for documentation is to improve the Landscape Committee's ability to track tree maintenance and to help make informed decisions about tree replacement.

Fortunately, we did not have to start from scratch. A "master plan" landscape map was created in 1979, and probably represented a vision of how the Mews community could look. The trees on the map were identified only as evergreen, deciduous, or canopy. Though a rough plan, one positive aspect of the document was that it detailed all the courts. In order for our current mapping efforts to

proceed, the map had to be hand traced and scanned as a jpeg. Each court was then cropped from the bigger map "picture" and made into its own page.

Tree identification was going slowly, until Kyle Thurman from Environmental Enhancements stepped in to lend a hand. In the course of several hours, work was complete. Now the data is being entered onto each of the court maps. A second, and sometimes third page follows each map and includes a table with the tree's common name, picture, web link, and room for notes. The maps are easy to update and provide a way to track tree maintenance. Take a look at the pdf of the trees in Court 4 on our web page as an example. More pages are coming soon.

Activity Court Repairs & Survey

In the Fall newsletter you were notified that the activity courts were being closed for repairs, which made many residents unhappy. We heard you! Steve Burcham completed temporary repairs and the courts were quickly reopened. The Board is continuing to investigate the best option, whether it is repair or replace. We'd like to thank everyone who participated in September's survey to determine the type of activity court that best suits our residents. The survey indicated that the majority of residents want the court to remain a combination tennis/basketball court.

The steps leading to the tennis court on 36th Street were replaced in October.

395 Express Lane Expansion

There are plans to extend the Express Lanes on 395 to the District line. Currently, the Express Lanes end at Rt 236 and are HOV only to the District. Carpools with three or more will continue to ride for free.

The plans also include expanding the reversible HOV lanes from two lanes to three. The website states that the third lane will be built within the existing footprint of the 395 HOV lanes. Construction is due to begin in Spring 2017.

- Enforcing any rules established by the Mews.
- Negotiating disputes between residents.

Neighborhood Reminders

RECYCLING



On Tuesday evening or Wednesday morning, residents may place the following items in the special recycling bins left at each court:

- Aluminum and other metal cans
- Glass bottles and jars
- Plastic containers

These items should be rinsed prior to being placed in the bins. No bags (plastic or paper) should be placed in the bins.

Mixed paper and cardboard can also be recycled. Mixed paper should be placed in a paper bag or tied with twine. Cardboard boxes must be broken down and flattened. These items should be left next to the bins.



TRASH COLLECTION

- Trash is collected six days a week, Monday through Saturday.
- Please put trash out by 8 a.m., but not the night before.
- Large items are collected on the first Saturday of each month.

PARKING RULES



- Each unit is assigned one parking space.
- Park only in your designated space or your vehicle may be towed.
- Visitors must park on the street unless using a specially designated visitor parking space.
- Call the posted telephone numbers to request towing or if your vehicle was towed.

PETS



- Cats must not be allowed to roam freely.
- All dogs must be leashed pursuant to Arlington County law.
- **Owners must clean up after their dogs.**
- No pets are allowed on the tennis courts at any time.
- Keep pets away from flowerbeds and border plantings.
- Do not allow dogs to bark excessively or leave barking dogs unattended on your patio.
